NEW! District 12 4-H Photography Contest

Status: CHANGE – RESUMING THE EVENT AND JUDGING PROCESS

Registration: Original dates 2/28/20 to 3/18/20. Deadline extended to 3/24/20.

Details: All entries were approved that remained in "Pending Status" starting May 5. Entries have been processed and the judging platform is being finalized with the judging to take place in the coming week.

District 12 4-H Shooting Sports Postal League

Status: CHANGE – PARTIALLY SUSPENDED / PARTIALLY RESUMED

Registration: Registration Closed 2/20/20.

Details: Details related to coaches/participants gathering has resumed in some communities/counties based on local directives and directives from the Governor. However, overall restrictions continue to impede many groups' ability to gather and complete the courses of fire. As a result, **the deadline for coaches to submit scores has been extended to June 22.** Follow the same processes in coach's packets for submission except for date changes.

Registration: Registration was scheduled for April 20-May 15 with Late registration from May 16-22 on 4-H

<u>District 12 4-H Officer Candidacy, Voter Registration & Election Process</u>

Status: NO CHANGE – PROCEEDING w/ CHANGES

Registration: New dates/deadlines - Candidates Applications & Voter Registration (May 1 - May 30)

Details: A letter on this process was distributed last month. Changes below:

- <u>Candidates</u>:
 - o Elimination of the requirement to attend either the Fall or Spring Council Meeting
 - o Application process remains the same and submitted via website & email (letter forthcoming)
 - o Possibly requiring candidates develop a 3-minute video presentation (pending)
- <u>Voter Registration</u>:
 - o No significant changes except for the Voter Registration deadlines/timelines

NEW! District 12 4-H Record Book Judging (July 7, 2020)

Status: **PENDING FUTURE DECISION**

Registration: Registration will be on 4-H Connect June 9 – June 30

Details: Record Book submissions and processes are being discussed by the committee along with implications for counties and how they handle and judge books at the county level. As of today (5/20/20), counties should proceed with their own local deadlines for county submission. There may be a revised approach for District and State record books coming soon.
